Dr. Michael Helgeson and Policy Director **Deborah Jacobi** were among the 350 national oral health leaders who helped author the Surgeon General's report, which also cited the respected non-profit's work to refine the role of oral health care providers and its findings that there is cost-efficiency for dental practices employing Dental Therapists (DHAT, p. 524), as well as referencing one of Apple Tree's Dental Therapists **Heather Luebben's** 2018 case study on Long-Term Care (p. 567).

Apple Tree Dental, one of Minnesota's largest critical access dental providers, operates eight Centers for Dental Health, located in Coon Rapids, Fairmont, Fergus Falls, Hawley, Little Falls, Madelia, Mounds View, and Rochester. Apple Tree provides preventive, restorative, and specialty dental services, while prioritizing care to underserved children, adults, frail elderly, and people with special needs. Founded in 1985 to bring dental services to frail elders residing in Twin Cities' nursing homes, Apple Tree has grown to more than 200 employees. To reach people of all ages, socioeconomic status, and cultural and ethnic identification, the organization partners with communities across the state to overcome the barriers that have made dental care unavailable and created serious health disparities.

Apple Tree's nationally recognized innovative delivery model includes Centers for Dental Health and onsite mobile dental programs in collaboration with 150 community partners such as long term care facilities, assisted living centers, nursing homes, Head Start Centers, group homes, schools, and other community locations.

As part of its mission, Apple Tree advocates for system change at the state and national level to enhance oral health policy and increase funding for oral health. Apple Tree's Leaders were instrumental in forging consensus between stakeholders which contributed to bipartisan support for a package of dental bills in the 2021 Minnesota legislature session to expand the availability, quality, and accountability of dental care in public programs.
