

I'm very excited to report that in 2023, after more than a year of planning, Apple Tree joined forces with ADT Dental, located in Minneapolis, and Ready, Set, Smile, an award-winning nonprofit that provides on-site services at preschools and schools in the Twin Cities. Dr. Adele Della Torre and Dr. Alice Ottavi, two outstanding leaders, built these two organizations and are extending their missions in collaboration with Apple Tree. With this growth, Apple Tree's teams are now close to 300 members strong.

During 2023, Apple Tree developed a new "flexible staffing" program to attract dental team members wanting extreme flexibility. Dental professionals can now choose when Apple Tree builds schedules that fit

OUR HISTORY

Apple Tree was founded in 1985 to address the barriers to care experienced by older adults living in nursing homes and assisted living centers. In 2023, Apple Tree expanded to nine brick-and-mortar Centers for Dental Health and delivered mobile care at about 200 community partner sites.

Oral health challenges

Minnesota children under age 6 are **1.7 times less likely** to have a preventive dental visit than children ages 6–17.

The overall **dentist-to-population ratio** is 1 dentist per 1,641 Minnesotans. However, in **rural or isolated areas, the number is 1 dentist per 3,938 residents.**

More than 1 in 4 Minnesotans are without dental insurance. More than 15 percent of Minnesotans had foregone dental care within the past year due to cost.

Every single county in Minnesota has **fewer than 55 percent of Medical Assistance enrollees** actually obtaining a **dental visit during the year**.

Apple Tree Dental has six Centers in Greater Minnesota, including two in towns with fewer than 3,000 residents. In 2023, Apple Tree joined forces with ADT Dental, a private practice in Minneapolis, and welcomed their entire team onto our staff.

With ADT Dental, Apple Tree is now affiliated with ADT Dental's sister nonprofit, *Ready, Set, Smile,* which provides on-site dental care and treatment to school-aged children.

Lily is a 23-year-old mom from Fergus Falls looking forward to getting married this summer. Earlier this year, due to extensive damage and abscesses, a dentist in northern Minnesota removed her top row of teeth. Unfortunately, they informed her that she wouldn't be able to get her denture made, or even get a cleaning, until a year and a half out—long after Lily's scheduled wedding date.



Lily contacted every dentist in the area, but most turned down her insurance. Apple Tree's Fergus Falls Center for Dental Health was able to get her in. Not only did she get a cleaning scheduled, but she was able to get all her appointments for her dentures in the books - which means that, by the time she walks down the aisle, she will have the smile she's dreamed about.








Percentage of patients on Minnesota Health Care Programs


